Policy Review

All Company Policies are regularly reviewed by senior management as required by the Policies Register in JLB Track, Documentation.

Quality, Environmental & Safety Policy

HYDI Limited (HYDI) is an innovative Australian company providing operators of heavy machinery throughout the world with an affordable solution for saving fuel, reducing carbon emissions and protecting engines.

Fundamentally, the HYDI unit is a 'Hydrogen on demand' system using distilled water and low voltage electricity from the vehicle or plant's electrical system to produce Hydrogen. No Hydrogen is stored and a number of safety features prevent Hydrogen being generated if the engine is not running. Our Australian designed, engineered and manufactured products reduce fuel consumption by 15%, particulates by 80% and carbon monoxide emissions by 25%, and create cleaner running engines.

HYDI is dedicated to the principle of continual improvement and maintains an integrated management system to ensure compliance with ISO 9001 for quality management, ISO 14001 for environmental management and ISO 45001 for workplace safety management. The system is independently audited and certified by JASANZ accredited certification body, TQCSI, to ensure our customers can be confident we consistently provide quality product and service while protecting the environment and maintaining a safe workplace for our staff and customers.

Management ensures, through ongoing training, that all staff are aware of the latest developments in their field of expertise and have adequate resources to effectively fulfil their duties. All staff are responsible for the quality of their own work and understand their responsibility to immediately alert management to any environmental and workplace safety issues.

Our business planning ensures quality, environmental and safety objectives are established and regularly monitored to ensure targets are achieved and the integrated management system continually improves. This is achieved through regular management meetings and, more formally, through management review meetings. Nonconformance and incident reporting, corrective action and internal audits complement our continual improvement process.

HYDI is committed to:

- meeting all legislative, regulatory, customer and other compliance requirements;
- the protection of the environment, including prevention of pollution and ensuring our products contribute to reducing carbon emissions;
